The Office of the Coroner for Madison County, Illinois is now taking applications to fill a single vacancy for a full time **DEPUTY CORONER/INVESTIGATOR**. This is a union position with a 12 month probationary period. Residency within Madison County, Illinois (suburban St. Louis, Missouri) is required. **Applications will be reviewed until September 21, 2016.**

### **BENEFITS**

Current Probationary Deputy Coroner/Investigator annual salary is \$44,033. Health insurance is provided at no cost to employee. Thirteen paid holidays per year with eighty hours vacation after the first year. Sick time is cumulative. Employees are participants in the Illinois Municipal Retirement Fund. ### **REQUIREMENTS**

To be considered for employment as a Madison County Deputy Coroner/Investigator, you must be a U.S. Citizen, a Madison County resident within 6 months of hire, minimum 21 years of age, possess a valid driver's license, have a clean police record, high school diploma or GED and, possess an Associate's Degree in law enforcement, nursing or related field and/or 3 years experience in medical technology, emergency medical service, law enforcement, nursing, or field employment in a medicolegal investigative office. Diplomate status with the American Board of Medicolegal Death Investigators (ABMDI) is preferred but not required for application. Probationary Investigators will be required to successfully achieve ABMDI-Diplomate status upon eligibility for examination or within two years of hire. Madison County Deputy Coroner/Investigators hold commissioned peace officer status with arrest powers. Qualification and carrying of a firearm is required as a condition of employment.

If you submit an application, you should be prepared for the following to be considered for employment:

1. Pass an extensive background check into your character, including but not limited to, criminal history check, personal references, independent references, prior work history, educational history, health issues and financial reports.
2. Pass an oral interview before a two or three member panel.
3. Pass a written test that focuses on your ability to compose a report that illustrates proper grammar, sentence structure and correct spelling.
4. Pass a polygraph (lie-detector) test concerning any prior illegal drug usage and other criminal activity.
5. Pass a psychological evaluation and written test.
6. Pass a physical agility test.
7. Pass a drug screen test.

All of the above-listed requirements must be met before being considered for employment. If you feel you are qualified and can pass all of the above standards, you may forward an application – retrievable at:
