#### **DEFINITION AND DUTIES:**

Under general supervision, conducts death investigations in the field and in institutional settings, issues cremation permits, acts as a liaison between the Johnson County Medical Examiner Department, other agencies and families of decedents, and performs related tasks. Supervises and assists staff engaged in death investigations.

- Be detail-oriented, quality driven and accurate while performing duties
- Handle low to high levels of stress, meet deadlines and solve problems appropriate to the position

Bachelor's degree in criminal justice, nursing or other closely related field AND three (3) years related experience OR any equivalent combination of education and experience which provides the knowledge and abilities necessary to perform the work. Certification as a Registered Medicolegal Death Investigator with the American Board of Medicolegal Death Investigators, Inc. Supervisory experience preferred.

**Special requirements:** Arrive at scene within one-half (1/2) hour of notification. Valid driver's license, safe driving record and insurable under county liability coverage. May also require use of private vehicle for official business. Completion of the Basic and Master's Medicolegal Death Investigation courses.

#### **SPECIFIC DUTIES:**

## The following duties are normal for this position. These are not to be construed as exclusive or all inclusive. Other duties may be required and assigned.

- Assist in the hiring, training, scheduling, motivating, evaluation and discipline of investigators.
- Supervise the daily work of investigators and insure investigations and supporting documents are comprehensive, complete, accurate and timely.
- Coordinate assigned work activities and assure staff coverage of investigations.

- Perform forensic death investigations to include such deaths as decomposed and skeletal remains, suicide, homicide, accidental, sudden unexplained infant deaths, fire, drowning, drug or poison related, motor vehicle, environmental exposure, and in custody deaths. Act as representative of the Department and consult with the medical examiner during the investigation.
- Organize and conduct monthly review and evaluation of investigations with Administrative Director.
- Manage department inventory of supplies and equipment required for death investigations. Restock supplies and equipment; maintain and fuel motor vehicles as required.
- Coordinate vehicle and equipment maintenance; clean and sanitize soiled and/or contaminated equipment, uniforms and motor vehicles.
- Handle bodies appropriately to ensure evidence preservation and conduct duties in a manner which shows respect for the deceased and their families. Observe standard precautions and utilize appropriate personal protective equipment. Collect blood, urine and vitreous specimens from the bodies of decedents.
- Measure, describe, photograph and record observations and witness statements at death scenes. Promptly respond to telephone inquiries as directed by policy.
- Perform routine duties associated with investigations and autopsies, particularly
  external examinations, identification procedures, investigative and clerical duties, as
  well as transmittal of results of autopsy and investigation to appropriate law
  enforcement agencies and other involved persons as directed by law.
- Serve as liaison with the medical examiner concerning autopsies, investigations, media relations and cremation permits.
- Follow-up on cases as guided by information developed through the autopsy, interview, investigation and/or laboratory findings.
- Obtain, review and retrieve documents and records which may include medical records, photographs, dental records, x-rays, and other items of evidentiary nature for identification and/or investigative purposes.
- Transport bodies in the designated vehicle or arrange for their transportation. Ensure proper identification, receipt, transfer, secure custody and adherence to infection control precautions.
- Assist in investigations outside of the County, including consultation with funeral directors, law enforcement officers, county attorneys, and other persons having legitimate interest in cases under the jurisdiction of the Johnson County Medical Examiner, and act as investigative liaison for the Department.
- Prepare cremation permits, open investigation if necessary and promptly transmit permit to requesting funeral directors.
- Assist in obtaining clinical specimens that were collected at hospitals and arrange shipment to locations as directed.
- Prepare and submit preliminary investigative reports and forms prior to the end of shift.
- Perform compassionate death notifications to next of kin and follow up with families as directed by policy.
- Assist in preparing and proctoring the Johnson County Adult and Child Death Review Teams.
- Assist in the preparation of the Johnson County Medical Examiner Department Annual Report.
- Present clear and accurate court testimony as needed.
- Notify Iowa Donor Network of deaths which meet their criteria for donor eligibility.
- Provide back-up for Medical Examiner Administrative Director.
- Attend work-related meetings and professional development activities as directed.
- Perform all work duties and activities in accordance with County policies, procedures, and safety practices.
- Attend work regularly.
