Duties include investigating the cause and manner of death resulting from accidents, homicides, suicides, or natural causes; or any death that is defined by the Kentucky Revised Statutes as a Coroner's Case. This is an appointed position in the Office of the Fayette County Coroner.

MINIMUM REQUIREMENTS

- 1. High school diploma or GED is required (KRS 72.415) and (18) months of college (or 45 college semester hours) plus (1) year of experience in a related field; or equivalent combination of experience and training which provides the required knowledge, skills, and abilities.
- 2. Upon appointment, must become a resident of Fayette County, Kentucky (Opinion of the Attorney General OAG 67-414).
- 3. Must be certifiable and obtain a Post-Mortem Investigator Certificate from the Kentucky Department of Criminal Justice Training after appointment to remain employed. Must complete at least (18) hours of additional training each year while in office.
- 4. Must have the ability to be bonded.
- 5. Must have physical strength and agility to permit the lifting and moving of cadavers.
- 6. Must be able to work outdoors in all types of weather and adverse working conditions and environments.
- 7. Possession of a valid Kentucky driver's license.
- 8. Must be computer literate including software such as Microsoft Outlook and Microsoft Word.
- 9. Subject to on-call duty.
- 10. Applicants meeting minimum requirements will be subject to a background investigation.
- 11. Applicants must become Registry Certified through the American Board of Medicolegal Death Investigators (ABMDI) within 2-years of employment.

EXAMINATION will be a training and experience evaluation from information provided on the application at the filing deadline date weighted at 100% of the final score.
