



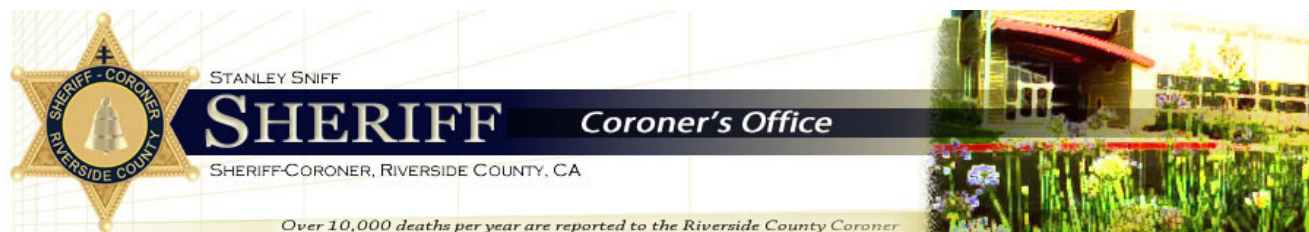

THE POSITION



Would you like to take your career in Forensic Pathology to the next level? The Riverside County Sheriff's Department is seeking a dynamic and accomplished **FORENSIC PATHOLOGIST III/IV** to join it's Coroners Bureau.

The Coroner Bureau operates out of two facilities in Southern California, in the cities of Perris and Indio servicing the County of Riverside with a population of over 2 million. In 2012 the Coroner Bureau, which includes four full time forensic pathologists and three part time forensic pathologists, performed approximately 1325 forensic autopsies in addition to external examination "consultations," with ancillary support provided by an on site anthropologist, contract odontologist and contract neuropathologist.

The selected candidate, under general direction, performs autopsies and other professional work in forensic pathology to determine the cause and time of death; testifies in court, and performs other work as required.

In addition to a competitive salary, Riverside County offers an outstanding benefits package. Benefits include medical, dental, and vision, paid annual leave, CalPERS retirement, monthly medical flex benefit, long term disability, life insurance, deferred compensation, (12) paid holidays, and bereavement leave.

This specialized classification is allocated to the Coroner's Office of the Sheriff's Department and reports to the Chief Forensic Pathologist. The Forensic Pathologist III classification is an underfill for the Forensic Pathologist IV classification. An incumbent at the III level has the necessary experience to provide the full range of forensic pathology duties; however, a III level incumbent is Board eligible for certification, whereas the IV level possesses Board Certification in Forensic Pathology. A Forensic Pathologist III incumbent is promoted to a Forensic Pathologist IV when proof of Board Certification as a Forensic Pathologist is provided to the Department.

SALARY RANGE: (Figures are based on approximate annual pay and qualification requirements):

Forensic Pathologist III: Board eligible: \$160,637 - \$193,656 annually

Forensic Pathologist IV: Board certified: \$169,424. - \$227,273 annually

EXAMPLES OF ESSENTIAL DUTIES

- Performs autopsies and evaluates historical and law-enforcement investigative information in order to establish cause and time of death and whether death was due to natural causes, accident, suicide, homicide, or is undetermined.
- Collects medical evidence such as trace evidence and secretions; performs chemical and/or microscopic examination of tissues and fluids, and submits samples of body fluids, tissues and other findings to laboratories for toxicology and clinical laboratory examination when analysis may be required.
- Prepares detailed reports of findings, confers with judicial and law enforcement personnel and assists in interpreting autopsy findings for the purpose of reconstructing events leading to suspected homicides or suicides.
- Signs death certificates, gives testimony at inquests, Coroner Review processes, and in court trials.
- Keeps informed of current techniques, procedures and equipment in forensic pathology; conducts special research projects as assigned.

RECRUITING GUIDELINES

Certificate Required: Possession of a valid Physician's and Surgeon's Certificate issued by the State of California

AND

Forensic Pathologist III Level: Eligible for certification in Forensic Pathology by the American Board of Pathology.

OR

Forensic Pathologist IV Level: Possession of certification in Forensic Pathology by the American Board of Pathology.

Knowledge of: Principles and practices of modern medicine and techniques of autopsy; statutes, ordinances, regulations and medicolegal issues related to Coroner's Bureau; the current and highly specialized techniques, investigative procedures and equipment applicable to forensic pathology including the applicability of toxicology, ballistics/firearm examination, trace evidence, forensic serology, forensic anthropology, and DNA technology; rules and regulations applicable to court testimony.

Ability to: Perform highly skilled post-mortem examinations; review and evaluate complex investigations, autopsy reports and other specific findings to establish the cause of death; communicate effectively and serve as an expert witness in a court of law, inquests, and legal proceedings; write and effectively interpret comprehensive reports; establish and maintain effective relationships with others.
